The insurer shall perform the requested changes and these will enter into force within 10 days after issuing of the final lease invoice. Upon changing the beneficiary, the insurer shall forward you a new policy.*

### Confirmations of the lessee

By signing the application the lessee confirms to be aware of the following circumstances:

- Submission of the application does not release the lessee from the fulfilment of their obligations arising from the lease contract.
- Upon satisfaction of the application by the lessor, the lessee may incur an obligation to pay the fees specified in the lease contract and the price list.
- The kasko insurance shall be valid until fulfilment of the contractual obligations. The lessee shall have the motor TPL insurance liability until the respective entry is deleted from the register.
- If insurance payments are made to the lessor, the total sum of insurance premiums calculated but not paid by the termination date of the insurance contract shall be subject to payment upon termination of the lease contract.
- The rights and obligations of the lessee, arising from the motor TPL insurance contract (incl. the right of cancellation of the contract, prepayment of or outstanding insurance premiums) shall transfer to the person with insurance liability (owner or responsible user in the register) as of making the entry in the traffic register. The new person with the insurance liability shall not be responsible for the transferred debt owed under the insurance contract if they cancel the contract within one month as of the acquisition of the vehicle. The transferor or the acquirer shall inform the insurer immediately of transferring an insured vehicle.
- The acquirer shall request changing of the data in the traffic register within 5 days as of the acquisition of the lease object. In case of failure to comply with the obligation, the lessor shall inform the Road Administration of the transfer of ownership, who shall temporarily remove the lease object from the register.
- I hereby authorise the lessor to inform AS Eesti Statoil of the termination and/or expiry of the lease contract tied to their debit card.
