- incapacity for work, unemployment insurance, and redundancy benefits, pensions, contributions to the third pension pillar, disbursements from the funded pension (based on TSD);
- entries in the employment register (information on the employer and the employment relationship);
- dividends and equity payments;
- tax arrears starting from 100 euros.

SEB will use the data obtained for the purpose of assessing creditworthiness. SEB has the right to make inquiries to the Tax and Customs Board only during the processing of an application. You may withdraw your consent at any time by notifying SEB thereof. The terms and conditions of the Tax and Customs Board for processing data are available on the website of the Tax and Customs Board. Please inform SEB immediately of all changes in the data provided in the personal data sheet that occur before concluding the contract of suretyship. SEB may refuse to conclude an agreement if it becomes clear that the information submitted is not correct.

SEB may communicate information, including information about your creditworthiness and the information of the contract of suretyship to be concluded, also to third persons (e.g. your spouse, the lessee of the lease obligation for which the surety is provided, and the provider of collateral) to verify the information submitted, evaluate creditworthiness, and prepare the leasing agreement and related agreements.
